Admission Requirements :

Students are accepted to study at the faculty according to the terms and regulations of the Ministry of Education and the university, taking into account the faculty's capacity, which are:

- Must have a high school diploma, science section, or its equivalent, with a cumulative average of not less than 65%
- Must be physically fit.
- Must be of good conduct and behavior.
- Must not have been convicted in a criminal or moral case or wanted by justice.
- To submit the original certificate.

Transfer to the faculty:

The faculty may, after the approval of the faculty's scientific committee, accept the transfer of students from other similar faculties and departments, whether from inside or outside Libya, if they meet the following conditions in addition to the conditions stipulated in Article (6) of these regulations:

.1-The student submitting the transfer request must commit to submitting the required documents approved by the previous faculty, attaching the courses he studied, provided that the last date for submitting the documents is 30 days from the registration of new students.

.2-The courses successfully passed by the student are equated by the faculty's scientific council, provided that at least 75% of the scientific content of the equated courses matches, and that the courses equated for the student do not exceed 50% of the courses required for graduation from the relevant department.

.3-The faculty may accept students transferred from similar accredited and recognized educational institutions within the available capabilities, in accordance with the terms and conditions set by the competent authorities in accordance with Article No. (62) of the General Regulations for Higher Education No. (501) of 2010 AD.

.4- specialized committee shall be formed to equate the qualifications of students transferred to the faculty by a decision of the Scientific Committee of the faculty. The equating committee shall begin the equating within a period not exceeding 30 days from the date of submission of the required documents. The faculty may enroll the student in the study according to an initial equating until the final equating procedures are completed. The student shall not be considered actually transferred until all required procedures are completed.

.5-The committee may recommend accepting the student's transfer or requesting him to complete remedial courses or rejecting the transfer for scientific reasons or reasons related to the capacity of the faculty or department.

.6-The student shall not be finally accepted into the faculty and registered in it unless he brings evidence of his release from the faculty or institute in which he was studying
